



On information and belief, I allege as follows:

At least until May 7, 2008, Keith Gross had a website at www.atlantaresults.com holding himself out as a real estate salesperson under the brokerage Jason Fox & Associates, Inc. This website allowed users to search current real estate listings and invited the public to contact Keith Gross at a toll free telephone number "for a private tour" of properties. A printout of www.atlantaresults.com as it existed on May 7, 2008 is attached for your reference.

Keith Gross is presently a candidate for the Georgia General Assembly. At least until May 14, 2008, Keith Gross was maintaining a campaign website at www.keithgross.com representing to the public that he is a "Realtor." A printout of this website is also attached for your reference.

According to Georgia Real Estate Commission records, Keith Gross' real estate license lapsed on November 28, 2007. I respectfully request that the Georgia Real Estate Commission investigate Keith Gross, license number 315691, pursuant to Georgia Code Section 43-40-27 for holding himself out as a real estate salesperson in violation of Georgia Code Sections 43-40-30 and 43-40-31 because it appears he does not hold a current, valid real estate license.

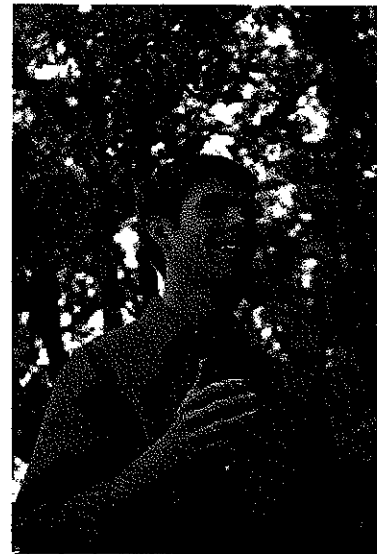
